

## Newfield Town Planning Board Meeting Minutes- April 6, 2016

The Meeting of the Newfield Town Planning Board was held at the Town Hall Board Room April 6, 2016 at 7 p.m. The meeting was called to order by Chairman Karen Trask at 7:04pm.

*Present were:* Karen Trask, Tom Gerow, Leo Tidd, Diana Bryant and Bob Mazourek. Also present: George Frantz, Phil McIntyre and one attendee (Gene Yapple)

**Privilege of the floor** was given to Gene Yapple who indicated his unhappiness with the planning board's current discussions of land use, particularly as it relates to agriculture. He also feels that we should be spending more time on bringing the community together that pitting neighbor against neighbor.

### **New Business**

Phil McIntyre of Delaware River Solar gave a presentation regarding the solar options in the Newfield area. Currently this company has no solar customers in the NY area. They are more of a financier for those who want to put solar on their land. Currently they are looking for people who have at least 10 acres of open land and are interested in having solar.

Documentation was handed out regarding the company and copies will be given to Town Supervisor Jeff Hart.

### **Old Business**

Reviewed the outcome of the March 26<sup>th</sup> Community Forums: Chairman Karen Trask presented an overview of the forum. (See attached) It was well attended, with great discussions and all were very respectful of each other's questions and opinions.

10. Can site plan review prevent a chicken farm or pig farm from being built in small residential area such as hamlet?
