Newfield Summer Day Camp Camper Code of Conduct

Every camper has the responsibility of treating everyone at camp with respect, this includes other campers, counselors, directors, and any other people working at the school or using the same facilities as us. Campers should be in control of their bodies, and their words at all times. Rough-housing, physical violence and disrespectful language will not be tolerated. We expect, and hope that you will have fun at camp, as long as your fun doesn't take away from another camper's opportunity to also have fun.

Campers are expected to listen to counselors and directors, and follow instructions as they are given.

Campers are responsible for coming to camp with a positive attitude and the willingness to have fun every single day of camp. We understand that you might not feel up to it every day, but still ask that you come in with the best attitude possible.

It is expected of every camper, that they will treat all Newfield Recreation and Newfield Central School Property with respect. Destructive or intentionally wasteful behavior will result in disciplinary action.

There will be plenty of fun activities scheduled for campers during the day. **Cell phones and other electronic devices are not welcome at camp.**

To Parents, we ask that you have a plan in place in the event your child needs to be sent home from camp, be it for health or behavior reasons. For bad, disrespectful, inappropriate, or dangerous behavior campers will receive discipline write ups. After 3 write ups campers will not be welcome back at camp. In extreme instances, campers may be asked to leave camp permanently for a single behavior

Every day campers need: a bag with a bathing suit, a towel, a change of clothing, sneakers, water bottle, extra mask and sunscreen. **All items must be labeled with the camper's name.**

I have read and understand the code of conduct above and agree to follow it. In the event a camper fails to/ refuses to follow the code of conduct, the Newfield Recreation Director, in consultation with the Camp Director, reserves the right to request that camper leave camp permanently.
