## **Ongoing Business:**

- Nancy's meeting with Supervisor Jeff Hart regarding Transfer Station and Hazard Mitigation plan did not happen. Scheduling problems.
- Jeff Golden also did not get a response from Supervisor Jeff Hart regarding setting up a meeting to talk about the Oct. 7 Collaborative Event, so will try to go to see him at his place of business.
- Supervisor Hart has Town Hall hours on Wednesdays mornings
- Barb submitted the application for the Planning Board Old Home Days booth to Jill Green.
- Karen Trask attending a Storm Water training session in Dryden, presented by Tompkins
  County. Will be attending August 20, 2014, the same day as Planning Board evening land use
  strategies training session.
- Michelle Henry attended water meetings Dryden working on a wetlands survey, may become a county wide project.

#### Town Board Report: Jeff Golden

- A third leach field for Newfield sewage system is needed. Present system is infiltrated and overloaded with wastewater. Near maximum capacity.
- No consideration or discussion of installing a town waste treatment plant at this time.
- Tom inquired as to whether an Environmental Protection Fund had a current program to replace old high water usage toilets with new water conserving models.
- Two more USGS test wells are to be drilled for quality monitoring to understand the aquifer and potential for new wells.
- New water meters can now identify excess water usage sources, affecting leach fields.
- Road preservation fee structure not completed.
- Discussion on procurement policy for employee purchases delayed.
   Discussion of whether to join the insurance consortium for Newfield Town employee health insurance.

# Land Use Regulation Training August 20, 2014:

- Nancy will confirm with training presenters Eric Miller and Joan Jurkowich
- All Planning Board members are to review Action Step 1 in Plan and have questions regarding planning tools ready.
